Official results of the recent STRS Board election were certified May 11, 2013. Incumbents Bob Stein and James McGreevy were re-elected to serve four-year terms as retired members. STRS provided vote totals as follows:

James McGreevy 21,311 Votes
Dennis Leone 20,533 Votes
Nadine McIlwain 10,199 Votes
Write-In Candidates 164 Votes

There was one open seat for a contributing member, but incumbent Carol Correthers ran unopposed. Stein, McGreevy, and Correthers will serve through August 31, 2017.

### **In Memoriam**

Rosemary Campbell, who had only recently retired from teaching at the Washington County Career Center, died April 5 at her home in Williamstown. Rosemary was a talented beautician/cosmetologist and had operated her own shop in Belpre for several years before going to work at the WCCC. "Rosie" was a great person and a good friend.

Carole Craig, who retired from the Belpre City Schools after 33 years of service, passed away April 22. Carole taught music and first grade classes and had been organist and choir director at St. Mark's United Methodist Church in Belpre.

WCRTA lost our oldest member on April 27 when Dennis Morris died at age 106.
